## Detailed Final Remarks/Comments

WE VISITED THE REGISTERED ADDRESS AT 0 CRP MD 17, INDIAN OIL PETROL PUMP, SHRAVANABELAGOLA RURAL, CHANNARAYAPATNA, HASSAN DISTRICT, SHRAVANABELAGOLA, KARNATAKA, 573135 ON 24TH APRIL 2025 AT 09:14:02. UPON ARRIVAL, THE ADDRESS WAS NOT FOUND, AND WE WERE UNABLE TO MEET ANYONE AT THE LOCATION. THERE WAS NO NAME BOARD VISIBLE, AND THE PAYTM QR CODE WAS NOT SEEN. THE AREA IS COMMERCIAL, BUT NO NAME PLATE WAS OBSERVED. MULTIPLE ATTEMPTS WERE MADE TO CONTACT THE APPLICANT VIA PHONE, BUT THE APPLICANT DID NOT PICK UP THE CALL AND REMAINED UNREACHABLE. INQUIRIES MADE WITH THE SURROUNDING AREA REVEALED THAT NO ONE WAS FAMILIAR WITH THE APPLICANT. BASED ON THESE FINDINGS, THE APPLICANT WAS NOT CONTACTABLE, AND THE LOCATION DID NOT APPEAR TO BE OPERATIONAL.
