THE AREA IS RESIDENTIAL, AND NO NAME PLATE WAS OBSERVED. MULTIPLE ATTEMPTS WERE MADE TO CONTACT THE APPLICANT VIA PHONE, BUT THE APPLICANT DID NOT PICK UP THE CALL AND REMAINED UNREACHABLE. INQUIRIES MADE WITH THE SURROUNDING AREA REVEALED THAT NO ONE WAS FAMILIAR WITH THE APPLICANT.
