UPON ARRIVAL, THE SHOP OWNER WAS PRESENT AT THE LOCATION. HOWEVER, THE APPLICANT DECLINED TO COOPERATE WITH THE VERIFICATION PROCESS AND REFUSED TO ALLOW THE CAPTURE OF ANY IMAGES OF THE SHOP OR HIMSELF. THE MSWIPE DEVICE WAS NOT OBSERVED AT THE PREMISES DURING THE VISIT. THE AREA IS LOCATED IN A COMMERCIAL ZONE, KNOWN FOR ITS CONCENTRATION OF ELECTRONIC GOODS RETAILERS, PARTICULARLY IN THE VICINITY OF RITCHIE STREET, WHICH IS A PROMINENT ELECTRONICS MARKET IN CHENNAI.
