WE ALSO TRIED TO CLOSE IN ON THE GIVEN LANDMARK; HOWEVER, THE SHOP OWNER REFUSED TO ALLOW US TO CAPTURE IMAGES OF HIS SHOP. ADDITIONALLY, THE MSWIPE DEVICE WAS NOT SEEN AT THE LOCATION. THE AREA IS LOCATED IN A COMMERCIAL ZONE. BASED ON THESE FINDINGS, THE VERIFICATION CANNOT BE SUCCESSFULLY COMPLETED.</p>
