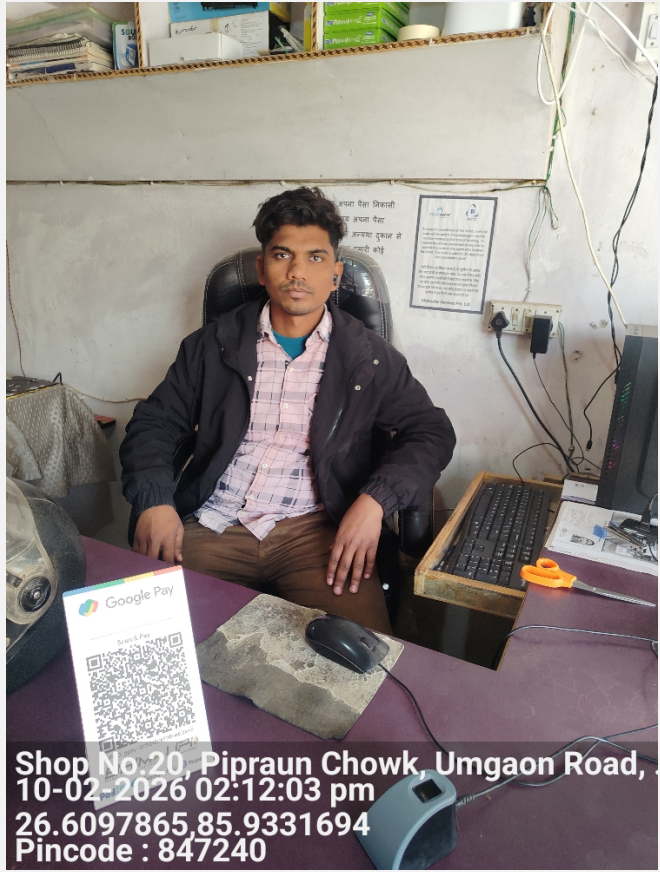



Photo of Machinery Setup
